The completion and return of the form of proxy shall not preclude shareholders of the Company from attending and voting in person at the above meeting (or any adjourned 8. meeting thereof) if they so wish.

A proxy need not be a shareholder of the Company but must attend the meeting in person to represent the shareholder. 9.
